As **CRONIMET TURKEY METAL TİCARET A.Ş.** ("CRONIMET" or "Company"), we show maximum sensitivity for the processing and protection of personal data of our visitors <http://cronimet.com.tr/> (" **Website** ") in accordance with the Personal Data Protection Law No. 6698 and its secondary regulations ("**LPPD Legislation**").

Within the scope of the disclosure obligation arising from the Personal Data Protection legislation of our Company, we would like to inform you about the cookies used by our Company and your personal data processed through this "Website Cookie Use Information Text".

Which Cookie Types Do We Use?

Cookies are small text files created by a website on your device that contain data in name-value format. Therefore, the cookies we use when you visit our Site make it possible to store information about your site visit on your device and to use this information during your next visits.

Cookies created by our site that can only be read by our site are primary cookies. The content offered on our site is provided through other domain names besides the domain name at the access address. In such a case, each domain name creates its own unique third-party cookies .

The types of cookies we use on our site and our purposes for using these cookies are as follows:

No.	Cookies Types	Intended uses
1.	Session Cookies	Session cookies are cookies that are valid during your use of the Website and remain valid until you close your internet browser.
2.	Persistent Cookies	These are cookies that are stored in your browser and remain valid until they are deleted by you or until the expiration date.
3.	Mandatory Cookies	These are cookies that are mandatory to use in order for the website to function properly and to benefit from the features and services offered.
4.	Functional and Analytics Cookies	Cookies that are used for purposes such as remembering your behavior and preferences during your visit to our site, using our site effectively, optimizing our site to respond to your requests, and containing data about how you use the site. Due to their quality, such cookies may contain your personal data. Through these cookies, for example, your language preference for viewing our Site is processed.

With the third party cookies we use on our site, we aim to provide you with a more efficient and more functional internet experience. A LPPD (KVK) Confidentiality Agreement has been concluded between these third party service providers and our Company in accordance with the LPPD (KVK) legislation and the security of your personal data obtained by these persons on behalf of our Company is guaranteed.

Storing and Accessing Cookies

Cookies created by our Site The website you use to access our Site is stored on your computer by your browser. Remote access to the information contained in these cookies is only possible by our Site , which is offered under the domain name <http://cronimet.com.tr/>, which constitutes the cookie, and if you use the same browser.

It is Up to You to Accept Cookies

Your internet browsers usually automatically accept cookies used on the sites you visit. The use of cookies is not mandatory to use our website, but if you set your browser to block all cookies, the quality of your user experience may decline and prevent you from accessing or benefit the various functions of our Site. Your browser; You can configure cookies to block all or specific sites to cookies, for certain sites, to alert when cookies are created, to block third-party cookies, or to count all cookies as session cookies.

Security of Your Personal Data

Security of Your Personal Data Cookies are not used for purposes other than those stated in this Cookie Information Text and all related transactions are carried out in accordance with LPPD (KVKK) legislation. Your personal data obtained through cookies are processed, stored and secured by our Company in accordance with the LPPD legislation.

Your Right to Get Information

Within the scope of Article 11 of the LPPD Law, by applying to our Company, of your personal data;

- (i) Learning whether your personal data is processed,
- (ii) To request information about this if it has been processed, to learn the purpose of the processing and whether it is used in accordance with its purpose,
- (iii) Knowing the third parties in the country or abroad to whom your personal data have been transferred, asking for correction if it is processed inadequately/wrongly,
- (iv) Requesting deletion / destruction within the framework of the conditions stipulated in Article 7 of the LPPD Law;
- (v) To request the third parties to whom the personal data are transferred to be notified of the requests for the deletion and destruction of your personal data within the scope of Article 7 of the LPPD Law and the correction of incomplete/incorrectly processed personal data;
- (vi) To object to the emergence of a consequence against you by analyzing your processed data exclusively through automated systems,

- (vii) We inform you to be entitled to request compensation for the damages in case you incur damages due to unlawful processing of your personal data.
